## <u>APPLICATION FOR EMPLOYMENT - POSITION OF DEPUTY JAILER</u>

INSTRUCTIONS: READ THE JOB DESCRIPTION IMMEDIATELY BELOW AND ELIGIBILITY BACKGROUND QUESTIONS IN SECTION V, BELOW, TO DETERMINE IF YOU ARE INTERESTED IN, AND ELIGIBLE FOR EMPLOYMENT AS A DEPUTY JAILER. IF INTERESTED AND ELIGIBLE, FILL OUT THIS APPLICATION IN YOUR OWN, LEGIBLE PRINT OR HANDWRITING. ANSWER AS TRUTHFULLY AND AS COMPLETELY AS POSSIBLE. ATTACH RELEVANT DOCUMENTATION WHENEVER POSSIBLE. STAFFING NEEDS AT THE JAIL VARY DEPENDING ON STAFF TURN-OVER AND OTHER FACTORS. ALL APPLICATIONS ARE REVIEWED BY THE JAILER, CHIEF DEPUTY, AND SOMETIMES OTHER STAFF. APPLICATIONS ARE KEPT ON FILE FOR ONE YEAR. THE MOST QUALIFIED APPLICANTS ARE CALLED-IN FOR JOB INTERVIEWS WITH THE JAILER, DEPENDING ON THE STAFFING NEEDS OF THE JAIL AT ANY GIVEN TIME. ALL APPLICANTS ARE SUBJECT TO PRE-EMPLOYMENT DRUG TESTING AND BACK-GROUND CHECK.

JOB DESCRIPTION: DEPUTY JAILERS HIRED DURING FISCAL YEAR 2009/2010 WILL TYPICALLY BE HIRED AT A STARTING WAGE OF \$8.50 PER HOUR ON A PART-TIME BASIS, LEADING TO FULL-TIME, DEPENDING ON JOB PERFORMANCE AND THE NEEDS OF THE JAIL. THERE IS A 6-MONTH INTRODUCTORY PERIOD OF PROBATION, AND DEPUTIES ARE NOT ENTITLED TO FULL BENEFITS UNLESS AND UNTIL FORMALLY PROMOTED TO FULL-TIME STATUS. NEW DEPUTIES RECEIVE AN INITIAL ORIENTATION CONDUCTED BY THE JAILER CONSISTING OF A 2 – 4 HOUR REVIEW OF POLICY & PROCUDURE, BASIC JOB DUTIES, AND TOUR OF THE JAIL. NEW DEPUTIES THEN RECEIVE 16 HOURS OF ON-THE-JOB TRAINING AND ARE THEN SCHEDULED TO WORK SHIFTS AS NEEDED. THERE IS NO BASIC ACADEMY OR FIELD TRAINING OFFICER PROGRAM. DEPUTIES TYPICALLY RECEIVE APPROXIMATELY 40 HOURS OF IN-SERVICE TRAINING THROUGHOUT THE YEAR, INCLUDING 16 HOUR OF DEPARTMENT OF CORRECTIONS TRAINING, QUARTERLY IN-HOUSE POLICY & PROCEDURE TRAINING, AND VARIOUS CERTIFICATIONS, INLCUDING 1 ST AID, CPR, PEPPER SPRAY, TASER, DEFENSIVE TACTICS, FIREARMS, ETC. ALL DEPUTIES RECEIVE AN ANNUAL COST OF LIVING RAISE SET BY THE COUNTY. DEPUTIES MAY PERIODICALLY BE ELIGIBLE FOR PROMOTION AND CORRESPONDING A PAY RAISE DEPENDING ON THE NEEDS OF THE JAIL.

DEPUTIES WORK UNDER THE SUPERVISION OF A SHIFT COMMANDER, TYPICALLY A SERGEANT OR CORPORAL, PRIMARILY INSIDE THE SECURITY PERIMETER IN DIRECT CONTACT WITH PRISONERS. DUTIES TYPICALLY INCLUDE: PRISONER ADMISSIONS AND RELEASES (SEARCHES, REVIEW LEGAL DOCUMENTS, INVENTORY PROPERTY, OBTAIN PRISONER INFORMATION, MAKE COMPUTER ENTRIES, PREPARE BONDS); SECURITY DUTIES (AUDIO-VIDEO SURVEILLANCE, CELL CHECKS, SHAKE-DOWNS, STRIP-SEARCHES, HEAD-COUNTS, PHYSICALLY RESTRAINING PRISONERS, USE OF WEAPONS AND RESTRAINT DEVICES, TRANSPORTS, MAINTAINING LOGS, AND PREPARING REPORTS); SAFETY AND EMERGENCY DUTIES (FIRE PREVENTION AND EVACUATION, PREVENTING AND RESPONDING TO ESCAPES, HOSTAGE SITUATIONS, RIOT, MASS ARREST, NATURAL DISASTER, AND SUCIDE ATTEMPTS); MEDICAL AND MENTAL HEALTH SERVICES DUTIES (ROUTINE MEDICAL, PROCESSING AND DISPENSING MEDICATION, AND EMERGENCY RESPONSES); FOOD SERVICE; SANITATION AND HYGENE; INMATE PROGRAMS (COMMUNITY SERVICE, WORK RELEASE, RELIGIOUS SERVICES, SELF-IMPROVEMENT & REHABILITATION PROGRAMMING, AND RECREATION); INMATE RIGHTS (ACCESS TO COURTS, VISITATION, MAIL, TELEPHONE, GRIEVANCES, AND DISCIPLINARY PROCEDURES).
